Introduction

In 2019 I was talking with the Director of Nursing (DON) at Pflugerville Nursing Care Center. Mutti was a resident at this Nursing home, and I was spending quit a bit of time there. It was a nice center with lots of activities and personnel. She recommended that I take a Certified Nurse Aide (CAN) course, because I was so good at taking care of Mutti. I seemed to have a natural ability.

I began a 6-week course on 22 March 2019 at Healthcare Career Centers. Mutti's health declined and I did not finish the course until 13 October 2019. I was certified until 13 October 2021.

In March of 2020 I briefly worked for BrightStar. About 2 weeks.

In July 2021, I took the online courses and applied for a 2-year re-certification. I was certified only until 3 July 2023, which is two years after my last date of employment. I had helped Catherine from 25 June 2021 to 5 July 2021 with caring for her face surgery wound.

In June 2023, I took the online courses and applied for another 2-year recertification. I had taken care of Chris from 30 March 2021 to 10 November 2021 during his heart attack re-habilitation. I was certified only until 10 November 2023, two years after my last date of employment (Chris).

I had to be tested for TB so I went to CVS on the 25th. But had to wait 2 days for my arm to be 'read'. I was negative.

The classroom work was 2 weeks. It consisted of 10 chapters, each ending in a test. We also had a test on Abbreviations, suffixes, and roots. That test was the hardest for me. I spent the whole two weeks studying for this last test.

Then one week each at two different Nursing Home Facilities We went to Bel Air at Teravista in Round Rock the first week Then we spent a week at San Gabriel in Round Rock

The rest of the class went on to the clinical practice lab. But Mutti's health had declined and she had fallen at the Nursing Home. She had cut the back of her head badly. HCC said that once Mutti's health improved, I could return and finish my clinical practice lab and take the final written and skills test.

2019 CNA Course August


Mutti's health did not improve and she eventually went into Hospice care, then died on 8 June 2019. I had to have some time to recover and to deal with distributing the estate. I decided to begin the course from the start again. Being part of the class dynamics is important to me. So, I signed up for the course again starting 26 Aug 2019.

The course consists of 2 weeks of Classroom lectures ending September 11th. Because of Labor Day weekend, our end dates were shifted.

Two weeks of practical skills in two Nursing homes ending September 25th. Two weeks in the practice Lab at HCC ending October 9th.

Then on Sunday October 13th have the Certification written and skills tests.

This time the Nursing homes were Falcon Ridge and San Gabriel.

As part of our Practical Skills test, we will be asked to do five of these skills while being observed and graded.

SKILL 1 — HAND HYGIENE (HAND WASHING)

- 1 Address client by name and introduces self to client by name put 2 paper towels by sink
- 2 Turns on water at sink
- 3 Wets hands and wrists thoroughly
- 4 Applies soap to hands
- 5 Lathers all surfaces of wrists, hands, and fingers producing friction, for at least 20 (twenty) seconds, keeping hands lower than the elbows and the fingertips down
- 6 Cleans fingernails by rubbing fingertips against palms of the opposite hand
- 7 Rinse all surfaces of wrists, hands, and fingers, keeping hands lower than the elbows and the fingertips down
- 8 Uses clean, dry paper towel/towels to dry all surfaces of fingers, hands, and wrists starting at fingertips then disposes of paper towel/towels into waste container
- 9 Uses clean, dry paper towel/towels to turn off faucet then disposes of paper towel/towels into waste container or uses knee/foot control to turn off faucet
- 10 Does not touch inside of sink at any time

Before we start the 5-skills we have to demonstrate that we can wash our hands. We have to follow these steps exactly. We are not allowed to touch the faucet or any part of the sink with our hands. Hard to avoid touching sink when it is a small bathroom sink with the tiny faucet.

SKILL 4 — ASSISTS WITH USE OF BEDPAN

- 1 Explains procedure speaking clearly, slowly, and directly, maintaining face-to-face contact whenever possible
- 2 Privacy is provided with a curtain, screen, or door
- 3 Before placing bedpan, lowers head of bed
- 4 Puts on clean gloves before placing bedpan under client
- 5 Places bedpan correctly under client's buttocks
- 6 Removes and disposes of gloves (without contaminating self) into waste container and washes hands
- 7 After positioning client on bedpan and removing gloves, raises head of bed
- 8 Toilet tissue is within reach
- 9 Hand wipe is within reach and client is instructed to clean hands with hand wipe when finished
- 10 Signaling device within reach and client is asked to signal when finished
- 11 Puts on clean gloves before removing bedpan
- 12 Head of bed is lowered before bedpan is removed
- 13 Ensures client is covered except when placing and removing bedpan
- 14 Empties and rinses bedpan and pours rinse into toilet
- 15 Places bedpan in designated dirty supply area
- 16 Removes and disposes of gloves (without contaminating self) into waste container and washes hands
- 17 Signaling device is within reach and bed is in low position

Every skill has detailed steps to follow.

The nursing assistant is a member of the home care team who works under the supervision of a registered nurse and performs various personal care services as necessary to meet the client's needs. The nursing assistant is responsible for observing clients, reporting these observations and documenting observations and care performed.

The nursing assistant will be assigned in a manner that promotes quality, continuity and safety of a client's care.

Essential Job Functions/Responsibilities:

Responsibilities of the nursing assistant include, but are not limited to the following:

- Provide client care as directed by the registered nurse supervisor.
- 2. Provide personal care:
 - a. Bathing
 - b. Grooming, including oral care
 - c. Assist the client with dressing and undressing
 - d. Assist the client with toileting activities
 - e. Assist in feeding the client, if necessary
 - f. Feed clients who are unable to feed themselves
 - g. Take and record vital signs (temperature, pulse, respirations and blood pressure)
 - h. Measure and record height and weight, if necessary.
 - Support good skin care to prevent skin breakdown (i.e. turn and reposition client, actively encourage movement)
 - Assist client with active and passive range of motions as defined by the plan of care
 - k. Provide client with help walking and transferring
 - I. Observe client's physical, mental and emotional conditions
 - i. Report any change to the nursing supervisor
 - ii. Document observed changes
 - m. Measure and document intake and output, if necessary
 - n. Assist client in the selfg administration of medication (medication reminder)
 - o. Perform light housekeeping
 - p. Perform meal preparation and clean up
 - q. Change bed linens and make up the client's bed
 - r. Maintain an orderly client environment.
- 3. Follow principles of infection control and Universal Precautions.
- 4. Identifies and participates in performance improvement activities.
- 5. Provide transport to doctor appointments, outside activities and shopping.
- 6. Participates in client teaching according to the client's plan of care.
- Assist in providing a safe environment and promote quality patient care through adherence to established policies, procedures and standards.
- 8. Ensure client's rights are adhered to. These include but are not limited to:
 - a. the right to privacy and dignity while care is being provided
 - b. the right to accept or refuse care
 - c. the right to confidentiality of their information
- 9. Respond rapidly and appropriately in an emergency situation
- 10. Use equipment properly and in a safe manner.




I worked the next Friday May 22nd 1pm-5pm, Saturday 23rd 8am-4pm, Monday 25th 10pm-8am (Tuesday), and Tuesday 26th 10pm-8am (Wednesday). Then I

resigned on the 27th Wednesday. The client that I was assigned to from 10pm-8am in Lakeway looked just like Mutti. I was stressing out. I would sit on the bottom of the steps so that I could look into their bedroom to make sure she was okay. Then when I did get home and tried to sleep, I would wake up at the slightest sound and have to go into Mutti's and Papa's bedroom to make sure all was okay. I expected to see Mutti in bed. A couple of times, when I did not see her in bed, I worried and checked the bathroom. I was losing it. I called my Physician at the VA Dr Ortiz on Friday and she said the situation was not good and agreed that resigning was the best action. And that I probably was not ready yet to take care of somebody else's "Mutti".

For a few days of work, 28.13 hours, I earned \$335.90 and took home \$310.20



2021 Re-certification July

In 23 March of 2021 Chris had a heart attack. After his surgery he went to Park Bend Re-habilitation Center. It did not go well and Chris ended up in the Emergency Room again. We convinced his heart surgeon, Dr King, that it was better for Chris to do his re-habilitation at my house. The house was still set up for Mutti and Papa and their re-habilitations. And I was a CNA. So, on 23 April, Chris moved in with me until 12 June.

From 24 June 2021 until 5 July 2021, I help Catherine with her wound care from her face surgery.


