


Hans' Documents 220120 Compendium

In August 1945, Hans' family had to flee their estate in Alt Raudten. Hans was a refugee until 5 June 1956 and received the following Refugee Identification.











In May 1950 Hans became a Photography apprentice. Below his Hans' Identification listing his profession as Learning Photographer in Wiesbaden Germany.




On 6 March 1953 Hans received a version of Driver's License for 'Kraftfahrzeug mit Verbrennungsmaschine' which mean 'motor vehicle with combustion engine'.



On 29 November 1954, Hans received a license to be a traveling salesman for the following year, 1955. The business states was for a "reisefotograf" traveling photographer.










On 24 June 1955, Hans received a German Passport. It was originally good until 1 July 1955,

but was extended to 31 May 1960.










On 19 November 1956 Hans received his immigration visa from the Consulate in Frankfurt Germany to enter the United States. Germany is under a quota system, and Hans' number was 82709. Hans arrived in New York on 8 March1957. This is the visa entry into Hans' German

Passport.

On 18 October 1957, Hans entered the Air Force. He was required to join one of the armed forces because of the draft. It also applied to an foreigner (alien) that had a green card or work visa. Hans was still a German citizen. Entering the armed forces does not automatically make a soldier an United States Citizen. The following is Hans' first evaluation report dated 17 October 1957. His first position involved driving Fuel trucks at the 7310th Materiel Squadron, near Milwaukee Wisconsin. In 1957, Hans' Air Force ID number was AF-16589642, not his Social Security number which is used today in the armed forces.

While Hans was stationed near Milwaukee, he met Helga Pörtner. Helga was also a new immigrant from Germany. They married on 1 November 1958.





Soon after their marriage ceremony, Hans was assigned to Germany so he left. Helga followed her husband later.








When Hans returned to Germany, although he was in the United States Air Force, he was still a German citizen and needed to have a German Identification card.. The following is one of

Hans' ID that he received on 11 January 1961 which was good until 11 Jan 1966.










While still in Germany, Hans became eligible for US Citizenship. The one benefit the US armed forces have to soldiers that are foreigners (aliens) is to fast track their path to US Citizenship. Hans only had to prove three years of US residency and the years being stationed on a United States armed forces facility (Air Force Base) is considered eligible. Hans had immigrated into the United States on 8 May 1957, and became a US Nationalized Citizen on 16 May 1961.



In 1959, while in Germany, Hans and Helga had a Daughter. Since in 1959, both Hans and Helga were still German citizens, their daughter was born a German citizen. In 1962 Hans was assigned to New Mexico United States. So the family moved to Roswell New Mexico. While stationed in New Mexico, Helga and her Daughter became eligible to become US Citizens on 8 September 1966. But before they could be considered for citizenship, they had to show proof of support. Hans wrote this 'Affidavit of Support' and had it notarized on 14 September 1965. His son had to be included in this affidavit because the son had been born on 24 December 1964.



Throughout Hans' Air Force career he took courses towards a degree. They were either in classroom at the base, or via the US Postal System. In 1994, while stationed in Maxwell AFB near Montgomery Alabama, he joined the Air Force Bootstrap program and could attend Auburn University full time. He Graduated on 13 December 1977 with a Bachelors' in Mathematics and minor in Physics.


